APPROVAL OF MINUTES:

- **c. Review quotes for emergency exit door replacements.** The Building Committee asked Director Mills to go back to Wunderlich Doors and request a new quote that includes the digital locks and present it at the next meeting.
- d. RFP for Landscaping and Snow Removal Services. Director Mills will work on creating a proposal specific to the library's needs to use to send out to Landscapers for the bidding process.
