NEW BUSINESS:

a. During Johansen and Anderson's annual service call, they uncovered rust and pinhole leaks on the oldest of the five furnaces. This can result in a carbon monoxide risk. Director Mills had two other companies come out, and they both found the same issues. Two of the three companies provided Director Mills quotes for a furnace replacement, and Johansen & Anderson was the cheapest at \$3,895. Karen moved/Vito seconded to replace the one furnace using

- Johansen & Anderson at a total cost of \$3,895. The motion passed with all members voting 'Yes".
- b. A parking lot update was given: all final contract paperwork is signed, and the project is moving forward. Bret will talk to the contractors about providing a timeline for when all the work will be completed.
- c. Smith Painting is going to start work on 9/13/24. They have two methods for removing the old paint. They hope to use the less noisy one to cause the least amount of disruption. They are also planning to do the front beams one side at a time so that patrons can continue to come to the library safely.
