Please accept the following Electrical Proposal regarding the *Shorewood-Troy Library – Parking Lot Lighting Feed Repair Project* on Deerwood Drive in Shorewood, IL based on email dated 11/26/2024 (Bret Mitchell), Site Walk-Thru with Jennifer Cisna Mills on 11/27/2024 and follow up phone conversation with Rey Gallego.

All work associated with the above-mentioned project is to be completed in a substantial workman-like manner. Any/all schedules provided will be contingent upon clean work areas provided by owner/GC in a timely manner and weather being moderate enough to work safely and productively.

• Electrical Base Bid (Lump Sum): \$5,990.00

Work Included in Proposal:

- Coordinate with J.U.L.I.E. prior to excavation. Locate existing underground conduits and lay out underground conduit repair.
- 2. Coordinate with Owner for access to all electrical closets as needed.
- 3. Excavate around (new) light pole base to expose lighting feed conduit stub.
- 4. Excavate from pole base to building with mini-excavator.
 - NOTE we will try to minimize but existing landscaping will be damaged. We have not included any funds to repair and/or restore landscaping. If required, repair/restore is by OTHERS.
- 5. Install ¾" GRS conduit feeder in new trench. Backfill with spoils and detectable caution tape.
 - Utilize no-thread coupling at pole base and GRS ¾" to ½" chang-over fitting at building.
- 6. Run fish tape in newly installed conduit and pull #10 conductors into building.
- 7. Locate existing circuit breaker and confirm it is powered off.
- 8. Splice new conductors at 1900 junction box above ceiling in basement of library.
- 9. Power on circuit and confirm functionality of existing (old) light poles by pedestrian sidewalk(s).

- 10. No Illinois sales tax included in quote.
- 11. No Local Permit/Inspection Fees/Consumption Costs/Bonding Costs.
- 12. No Weekend Time/Holiday Time/Shift time/Overtime.
- 13. No Temporary Power/Lighting included in pricing.
- 14. No Saw-cutting, Spoil Removal or Landscaping Repairs included in pricing.
 - Backfill conduit trench with spoils is included in quote.
- 15. New Lighting Poles/Lighting Fixtures Furnished/Installed by Others.
